Membership Indemnity/Disclaimer

This form must be read and signed by all persons applying for membership offered by Murraylands Gem and Mineral Club Inc., hereafter referred to as MGMC Inc.

I am aware that there are potential dangers and inherent risks associated with any club/society activities, excursions, and expeditions involving both indoor and outdoor activities in all areas, which include but are not limited to workshops, classes, mineral handling, camping, fossicking, caving, and hiking.

I accept full responsibility for loss as a result of personal injury, illness, loss of life, or loss of property that I may sustain during the activity/field trip offered by MGMC Inc.

I hereby expressly indemnify MGMC Inc., its directors, organisers, staff, helpers, and agents as well as any and all landowners, land managers, mining managers, and any and all persons associated with such from any liability arising in Common Law or by Statute for injury or death or loss or damage to property arising from any cause whatsoever.

I certify that I am fully capable of participating in the outlined activity/field trip. I will obey the lawful instructions of MGMC Inc. appointed officers/field officers with regards to all aspects of the activity/field trip and its safety.

Rescue and medical assistance

In the unlikely event of rescue and medical assistance being used other than provided by MGMC Inc., the participants shall be liable for the entire cost thereof.

Children and youth (people under the age of 18)

Participation of children less than 14 years of age is acceptable only if a parent/guardian accompanies them. The legal guardian of anyone under the age of 18 years of age is required to sign the relevant indemnity forms and supply any personal information as may be deemed appropriate by the relevant MGMC Inc. appointed officer/field officer. (Relevant, in this instance, relates to the specific activity/field trip that participants will be engaging in as well as this indemnity form.)

Photos and Videos

Invariably, photos and sometimes videos are taken at club activities by the club, club members, and sometimes by the public. While the club cannot guarantee anyone from being included in shots taken, it will endeavor to cooperate with any person specifically requesting not to be included. This also applies to personal picture inclusion in the club newsletter and notice board. If you wish to be excluded from photos/videos, it is suggested that you request any person about to include you in a shot not to do so. Likewise, apprise either the club president or the club secretary in regard to personal pictures being excluded either from the newsletters or notice board, or both.

Insurance

Participants are advised that they may take out travel insurance at their own cost if they so wish. Please be aware that your insurance should cover the activities associated with MGMC Inc.

Deposits and payments

A non-refundable deposit of \$----per person/vehicle per activity/field trip is required to be paid to the MGMC Inc. appointed officer/field officer at the commencement of an activity/field trip. Any other costs/fees associated with any activity/field trip as outlined in the planning stages of the activity/field trip must also be paid to the officer/field officer prior to the event.

There exists no other terms and conditions regulating their relationship.
